Angelina Barclay is a client of UCHRA's Substance Abuse Solutions (SAS) program. The following information was provided by the client and has been edited for clarity.

Angelina Barclay was homeless; crashing on friends' couches.

"I was left homeless after being kicked out by someone I trusted," she recalled.

One week later, a friend put Angelina in touch with Luke (Eldridge), Recovery Services Manager with the Substance Abuse Solutions program at Upper Cumberland Human Resource Agency (UCHRA).

"He helped set me up in a hotel, where I stayed for six months until I got a meeting with the Crossville Housing Authority," Angelina recalled.

With the help of UCHRA's Substance Abuse Solutions team, Angelina was finally able to get her own place and regain independence and stability.

"Luke and the rest of the UCHRA SAS team have been endlessly helpful, always ready to answer questions, and provide support and resources," Angelina added. "Thanks to their tireless efforts, I have regained my hope for a better life, and am working every day to make my dreams a reality."
